**ARPA FUNDS – Town of Hillsboro (Tom Fishero)**

Tom Fishero said the bids on the sewer project came in much higher than expected. They will be approximately \$130,000 short and are therefore requesting an additional amount of \$170,000 to complete the project. The higher amount will cover any other unexpected costs. The bid is good for 90 days. The Commissioners have asked Roger Azar to go over the proposal. He will then contact some area vendors that may be able to do the work for less money.

Jim Hershberger made a motion to give the Town of Hillsboro an additional amount of \$130,000 for their project contingent upon Roger Azar’s investigation of the pricing/vendors. Tom Booe seconded the motion. Vote: 7-0

**DEPARTMENT HEAD REPORTS**

**Ambulance – Garth Kagels**

Garth reported that they have moved forward with NSure. They will re-evaluate it in a couple months to see how it is performing. Also, there is no news on the new ambulances or the chassis. Ivy Tech of Lafayette will be having a paramedic class with funding through Ivy Tech. He has also talked with Lisa at the Williamsport Learning Center about classes but does not know when they will be conducted or the cost.

**Sheriff – Terry Holt**

They currently have 75 inmates. Thirty-two of these are out of county. They have averaged a little over 68 inmates per month for 2022. Tom Booe asked about SWAT training. Sheriff Holt reassured him that his deputies have had some training and knew how to work with the SWAT teams from different areas when they were called in for these kinds of situations.

**Clerk – Paula Copenhaver**

Paula stated that the swearing in ceremony for newly elected officials will be December 19, 2022 at 11:30 a.m. in the Courtroom.

**EMA – Joe Whitaker**

Joe informed the council that the repairs on the tornado siren will not take place before the end of the year due to a parts shortage. He will have to ask for an additional after the first of the year as there will not be an invoice available to encumber the funds.

**Coroner – Joshua Whittington**

He informed the Council that he is working with the Auditor to move funds around to pay bills for the remainder of the year.
