DEPARTMENT HEAD REPORTS

AMBULANCE – Garth Kagels

Garth reported that he will meet with Horton on August 15 to go over the pre-construction specifications on the new ambulances. There is still no timeline on the new chassis. The concert last weekend at the Badlands went well. There were approximately 5,000 in attendance. He will have one employee on FMLA due to back surgery. The lights in the parking lot have been installed and the driveway has been sealed. Dudley asked a question in regards to billing. During the council conference he learned there was a law change in regards to an ambulance run. They can charge up to 4 times what the hospital charges on the Medicare rate. He asked that Garth call AIC to get more information.

REVIEW OF REQUESTED BUDGETS FOR 2023⁴

The Council reviewed the budgets of the Auditor, Assessor, Recorder, Coroner, Landfill, Plan Commission and the Soil and Water. The Department heads/elected officials were present to go over their budgets with Council and answer any questions.

Discussion – Health Board

Dudley went over how the new health board will be formed beginning January 2024. The health director does not have to be a doctor but must have a master degree in public health.

There was discussion in regards to the Plan Commission and the permits.

Denise Crowder made a motion to support Jim McKee in making a recommendation to the Plan Commission to charge a permit fee for renewable energy. Kelly Carlson seconded the motion. Vote: 6-0

Council also discussed budgets, funding and new projects. Dudley handed out information that he received at the County Council conference in June.
