COMMISSIONERS – Courthouse / New Jail

Craig Stalter and Don Hesler spoke about updates on the Jail and how the electrical part of the Jail is getting close to being completed. There has been some damage to the new kitchen due to Muriatic Acid being put into the lines and getting all over the stainless-steel appliances which caused the appliances to rust. Glesco has been notified and they are coming to the Jail to assess the damages. The Health Department may not approve the opening of the kitchen due to this issue.

The Sheriff's department has hired jailers and they are needing to be trained at the new Jail. It was suggested that if the courthouse needed help with anything that they could come over here to work in the meantime. They are hoping that the new staff can start training at the new facility on February 24, 2020.

Encumbrances - Circuit Court

Brenda has spoken to the Judge and the issue has been resolved over the encumbrance requests. The Judge is going to wait until later in the year and ask for an additional appropriation if needed.

COVERED BRIDGE - re-establish tax rate for Cum Bridge for 2021

The Council would like to re-establish Cum Bridge tax rates to collect .005 for the covered bridges and reduce the Health Fund by that amount so that the taxes aren't increasing for the taxpayers. This will need to be done by April 30, 2020.

A motion was made by Tom Booe and seconded by Jim McKee to approve re-establishing the CUM BRIDGE tax rate for 2021. Vote: 5-0




