#### Ambulance – Garth Kagels

Garth went over the overtime pay with the Council. He has filled all but one paramedic spot. Garth said it has been difficult to fill the positions with part time people. Denise Crowder was concerned that we don't have enough fulltime people according to the figures given. Garth also requested an additional in the amount of \$200,000 for overtime to finish the year. They received the first ambulance on Friday and the other should be ready on Wednesday of this week. The re-mount has been pushed back to late November or December.

#### Health – Jenny Eads

She has received a new contract for the lease of the Health Department building. It is a 5-year lease with a 6-month early termination clause. The rent per month is the same.

## **Public Comment**

Brad Crain – Covington Mayor asked why the County did not include the 250 feet from the Dixie Bee intersection on Stringtown Road to the railroad bridge going into Covington. Jason Lewis stated that it was not in our INDOT inventory. Brad would like to see that section paved. He will be getting a quote from Milestone on the cost.
