#### **Commissioners - Courthouse Heating/Cooling**

Studies were done by Ameresco for heating and cooling and we are awaiting the results from Mark Heirbrandt to appear before the Commissioners with their findings. The commissioners have been looking into the current heating and cooling in the courthouse. Studies have been done to see the humidity level and the approximate electrical cost per day (\$100) to heat/cool the building.

The chimney needs to be reduced and capped. Scott Williams has been the contact for looking after the boilers and he feels that they need to be rebuilt. They do know that the main controls need to be replaced and that will cost around \$10,000. Most of the cost would be for the labor.

Jim Hershberger proposed that they move forward with the revitalization plan based on the proposals that Scott and Mark present to the county.

The committee has been formed to go through the invoices to see what will be approved to get a reimbursement from the grant. The committee includes: Brenda Hardy, Dudley Cruea, Tina Holmes and Joe Whitaker. The lawyer working with them is Jake German from Barnes & Thornburg.

#### **Department Head Reports**

#### **Sheriff - Terry Holt**

As of today, the new Jail is housing 42 prisoners. 11 female and 31 males. The old jail is averaging about \$1,700 a month for utilities. It will be disconnected as soon as everything is out of the building. The new jail is averaging about \$5,000 a month for utilities.

#### **Ambulance - Garth Kagels**

They have been exceptionally busy lately.

The 2008 Ford Expedition (Garth's Vehicle), the PCN – main control panel has gone out. To fix it will be \$1,600-\$1,700. There are other issues with the vehicle such as rust issues, etc. The Commissioners have opted to replace the vehicle. Garth is getting quotes of new ones and will let the commissioners know as soon as he has the information.

Garth and Terry Holt are getting prices on signage to have the EMS lettering match the new Jail. They are waiting on an answer from Rob Dawson.

He has a position to fill and is having a hard time finding paramedics.
