He is attending Indiana University in Bloomington and is majoring in Law & Public Policy. He needs 120 hours of experience for his degree. He will be spreading out his time between a few offices within the Courthouse. There are funds in the Part time custodial line (\$1900). That line item can be used to pay him.

DEPARTMENT HEAD REPORTS

Ambulance – Garth Kagels

The reductant heater went out in one of the Ambulances. It has been fixed, but they have found out that it was recalled and are working on recouping funds. The Med Shed is still having sewage issues. It is still backing up in the same place. Roger Azar will be going over on Thursday to run cameras to determine the next best course of action to resolve the problem. The whole system may need to be reconfigured.

Highway – Jason Lewis

They were awarded the Community Crossings Grant in the amount of \$1 million. The County portion is for \$250,000. Milestone was the lowest bidder. They would like to do a comparison of the material used versus what Reith Riley used in a previous job. They have sold 5 trucks to Enterprise. Four Dodge trucks, receiving trade in value of approximately \$41,000 each. Rusty’s old truck (Chevy), was about \$36,000. So far, they have received 9 of the 13 vehicles coming from Enterprise. The last 4 should be received in September. They are for the mechanics. The County is in desperate need of a salt barn. The County is losing 35-40% of the salt a year do to it sitting in the weather, bleaching and washing away. Jason received a quote from Greystone. It will be around \$260,000 for the barn. It would be 65 ft wide x 80 ft long. The council would like to possibly use ARPA funds to cover the cost. Two more bids are needed. The Highway Department is receiving 2 Graders in July. They are \$350,000 each.

Coroner – Joshua Whittington

He has been borrowing a cot for the Coroner Van for a while now from Maus Funeral Home and it is 30 years old. It is not equipped for what he needs. They need to purchase their own. The Commissioners have already voted in favor of the purchase. The Council also agreed.

Sheriff – Terry Holt

Two chillers went out. They were struck by lightning. The insurance company will be taking care of the costs.

Mental Health Summit

One Commissioner, Council member, Probation officer, Prosecutor and one from Sheriff's office are required to go. It is October 21, 2022 at the Indiana State Convention Center.

Economic Development Board

A citizen is needed to sit on the board. They have to have a business for at least 5 years and it can't be a committee member.

IT Department for 2023

Dudley would like the other Council members to think about whether or not to go with a full time IT County Employee for the 2023 Budget.
