The council decided to charge \$30 for military vehicles. Taylor Powell, Council Attorney, will prepare the Ordinance.

READI GRANT – Grant Britzke

Mr. Britzke gave an overview of the Child Care portion of the READI grant. It is a multi-county project to build child care in the area. There is money for 430 spots divided among the participating counties to provide licensed, quality and educational day care. The money for the County match stays in Fountain County. The start up costs for new childcare is approximately \$1,000 per child. They have received one application for Fountain County. Dawn Gritten of Community Action Program was in attendance to gather information for her agency. She is in charge of the child care program with Community Action and they will be applying. Veedersburg and Attica are working on a child care program. Kim Kalweit of WEGA will be meeting with the area schools.

Zoning – Roger Azar

Roger handed out a map of Fountain County with the proposed changes to the Zoning map defining residential, business, industrial, agricultural, exempt property and utilities. Jim McKee will be going to the Attica and Veedersburg city council meetings to have them determine the 2-mile radius on their zoning ordinances. Roger was seeking approval from the Council before moving forward in which the Council did give their approval. The next step would be a public hearing and then onto the Commissioners for approval.

DEPARTMENT HEAD REPORTS

AMBULANCE – Garth Kagels

He received a quote for the Big ASS (Name of Company) Fans in the amount of \$19,013.63. A representative from the company is to be at the Med Shed today (9/11) to make sure they will do the job. He will also ask them about the wiring for the fans. Garth requested that the council wait on making a decision until he has talked with the company.

E 911 – Dana Stonebraker

Dana handed out a quote from Caliber on a new CAD system. She has been negotiating with Caliber and this is the 3rd quote in the amount of \$196,169. It has been reduced by \$90,000. They will come train the employees. They will also be on site one time a month. They will also need new hardware for the new software in the approximate amount of \$30,000. This amount has been included in the grant application.

Budget Hearing

The Council met with the following department heads/elected officials to review their 2024 budgets: County Highway, Ambulance, E-911, Circuit Court, Sheriff and Health Department. Review and discussion was heard on the remaining budgets. It was determined to have a special meeting on September 25th at 5:30 p.m. for further discussion.
