Health Department Building Purchase

Jeff Fishero discussed the details on the repairs to the crawl space that will be done by Indiana Foundations. They will capsulate, add dehumidifiers and sump pumps, and guarantee it for the life of the building. There will minimal ongoing fee for annual inspections done by Indiana Foundations for any repairs needed. Also adding a generator outside. They will also have battery back up for dehumidifiers and sump pumps. The purchase price was reduced by about \$50,000 to cover repairs. Seller still doing some gutter and exterior repair. We will need to do some digging to get the septic to the hookups.
