Linda Reynolds was worried that her road on west Dixie Bee has vision issues. She has spoken with Brad Crain and will speak with Jason Lewis.

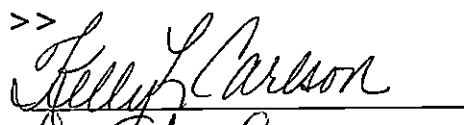
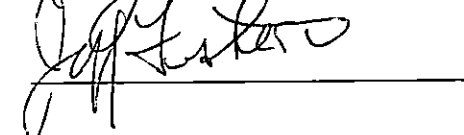
