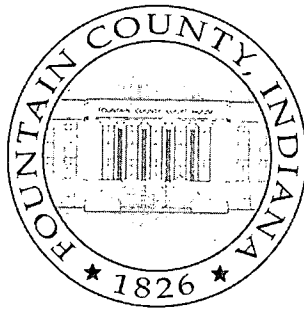

Patty Smith – Clerk

Patty said the primary went off without a hitch. There were no major problems. She said there were 11,894 registered voters. On election day, there were 4,032 ballots, which is roughly 34%. Out of the 4,032, there were 767 early voters in person, 66 mail ballots and 7 travel. The highest precinct turnout was Jackson Township with 43.82% and the lowest was Davis Township at 24.39% turnout. The election costs were slightly over \$30,500.00. No official word on the recount for Senate District 23. She already has talked to the State police regarding the procedure. The Clerk's office will be closed on May 22 as their holiday for election day. She is currently having all marriage books scanned and digitized, which is currently being done in the Community Room.

Wayne Laswell – Ambulance

Wayne said equipment should start coming in at the end of this month. Billing is fully outsourced now. Three of the iPads out of six are in service. Everything should be fully digital now. This week is EMS week. He said the department has been working through their loss. He stated when he was offered this job it was for a certain pay, but when it was accepted it was a lower pay. It has been a cut in pay. He had talked to Jeff Fishero, who said they would revisit the pay in April. Wayne was not sure he could take the cut in pay. Wayne is getting to the point where he is stretched thin personally, financially and personally. He would like to know if they are going to discuss or what he needs to do to receive the back pay. He is not sure what to put for next years director pay. He has got rid of overtime and this is the first full month of billing. He said this month will give a good idea of what the billing will look like. Kelly Carlson asked if he had done his budget. Wayne has started on it. Kelly said they will go over his budget during budget hearings. Kelly said they will have a discussion and get in touch with Wayne.

Kim discussed grants for the Community. These will not open until February 2027.

Dana Stonebraker – 911

The non-emergency number is working better.

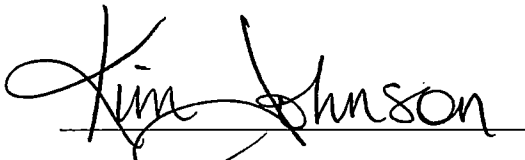
