Also, the commissioners spoke on the issue of Insurance. They are going to stay with SIHO for the time being and put a freeze on any new full time hiring. The deductibles may be increasing and employees will have to pay more if they go out of network.

**Garth Kagels**—they have purchased the vehicle from the city and it needs new red lights put on it. It also needs some paint in a few spots.

At the last meeting, he spoke about receiving money from Medicaid. He has been in touch with them again and they are hoping to receive the money sometime in January.

**Leslie Chilcote**— she is the owner of the Northside Pub. She was expressing some concern about the liquor board. She is having some issues. She wanted to know the obligations of the board, how they get appointed and for how long.
