**Don Hesler**—there is a balance of \$337,001.43 as of January 1, 2014 in the E-911 Statewide Fund. The commissioners are suggesting that \$200,000 of it be used for the in conjunction with the Rainy Day Fund. Also, the commissioners would like to see about giving the 911 director, Kathleen Osborn a raise. It is not in the original budget, so it has to be approved by the State Board of Accounts. She is operating with fewer people and taking on more shifts and is not being compensated extra for it. One other thing that was brought up was outsourcing payroll. The purpose of doing this would be to balance out responsibilities in the office and possibly make billing run more efficiently. Jon Ireland is coming today to meet with Brenda Hardy, Don Hesler and Craig Stalter to discuss what they can do.
