<u>Keystone Insurers Group-Joni De Souza</u> - was here to answer any questions that the council may have about the insurance and give her recommendations to help save the county some money. She believes changing the deductibles is the best way to save some money. The council and commissioners are in agreement that there needs to be an increase in the deductible or have an HSA account. She will be preparing a projection for the council and commissioners to show what the employees can expect to be paying.
