BUDGET HEARINGS

Bud Peach (Co Highway), Garth Kagels (Ambulance), Bill Sanders (Sheriff), Don Hesler & Tim Shumaker (Commissioners), Brenda Hardy (Auditor), Sandy Whitaker (Assessor), Judge Henderson (Circuit Court), Wanda Taylor (Recorder), Bob Cates(Vet officer), Terry Martin (Pros Attorney), Dr. Sean Sharma (Health Dept.), Courtney Stierwalt(Purdue Extension), John Kirkpatrick(Soil & Water), Colleen Chambers(Treasurer), Joe Whitaker(EMA), Paula Copenhaver(Clerk) and Kathleen Wesley(E-911) were all seen by the council to go over their budgets. Co Drug Free Community and the Coroner's budgets were also discussed without representation.

Budget Review

The council needs to cut over a million dollars from the County General Budget. Most department heads asked for a 2% raise but, some asked for 3 or 5%.

Bud Peach- County Highway

He requested new wages for his laborers, mechanics, foreman and superintendent which calculated close to 3% increase in wages.

He is also requesting a new dump truck. Truck #39 has too many miles on it and they would like to start using truck #6. Truck #6 would be replaced with a smaller, more fuel efficient truck.

Garth Kagels - Ambulance

Linda Galloway will be retiring in March of next year. He asked permission to replace her. He would like the new person to start training in December to get the maximum amount of training which would include annual reporting and other monthly reports.

He determined that outsourcing 3^{rd} party billing would not be beneficial. The county would still have to pay for a part time person to get the bills ready to send to the company and the company gets 8% on top of that.

He requested additional funds to purchase an electric cot and new defibrillator. The department has Life Pak 12 and after the end of this month, they will no longer be able to be serviced. Life Pak 15 is what he would like to purchase. They were turned down for a grant for those items.

He expressed gratitude for the new ambulance that was purchased. The 2010 ambulance is starting to have a lot of problems and he recently found out that it could be re-chassis. There is another truck that can have the same thing done. They both could be done for around \$230,000. If you buy a new ambulance it will be around \$200,000 for just one.

Bill Sanders-Sheriff

He requested 5% raise for the deputies and 3.1% for himself. He also requested 2 more deputies and 2 vehicles.

Administration of Records Fund can help pay for the person in charge of keeping track of the records.

The additional appropriation has already been done for the purchase of the new cameras to be installed in the jail. He will make the call to proceed with the installation.

Sheriff retirement: it has been requested for the retirement to be amended and put into the 26 years bracket. As it stands now, it is capped at 20 years of service. For the 2016 budget it was budgeted for \$53,094.00 and they are requesting \$56,261.00 for 2017.

Judge Henderson- Circuit Court

The Judge thanked the Council Members for all of the years that they have served in office while she has been Judge and has been associated with the County. She asked that the Court Reporter position's salary should be changed to \$32,000 instead of \$34,935.00 due to it being a newly filled position in 2017.

Terry Martin - Prosecutor

The department will be donating \$2,500 to Hope Springs Safe House and he will be asking for additional appropriations out of (1182) Pre-Trial Diversion to be acted on next month. They will also be donating to Beyond the Violence. The Prosecutor expressed concerns for possible lack of funding in 2017 for the 13 pays for the Transport Officer which is paid out (2400) Infraction Deferral. The other 13 pays is budgeted in the County General Sheriff's Budget.

PETITION REQUEST- VAN BUREN TWP TRUSTEE - KAREN SEIBOLD

There is no particular format or structure for the unit's petition; a letter would suffice. The petition should include the unit's proposed budgets, levies, and rates so that there is no question as to what was approved if the county council grants the petition.

• The Department very strongly recommends that the county fiscal body public hearing AND county fiscal body determination occur on or before November 1, 2016!

The county fiscal body should issue its determination in the form of an ordinance or resolution. Again, this should occur on or before November 1, 2016.

- The county fiscal body "may grant or deny" the unit's petition for an increase in its budgets; statute does *not* authorize the county fiscal body to modify (reduce) the unit's proposal.
- Notice of the public hearing is governed by the Open Door Law (48-hour notice); to the extent the unit and county fiscal body can coordinate and allow for enough time, the Department strongly recommends that notice of the hearing be published in the correct newspaper(s) at least ten days before the hearing.
- Upon receipt of the county fiscal body's determination, the city, town, or township must upload a copy of the unit's petition and a copy of the county fiscal body's determination to Gateway within 48 hours of November 1, 2016.
- In this situation, the unit will not have a Form 4 to upload. The unit must still upload all the other budget documentation (e.g., Form 3).
- In the event a city, town, or township subject to IC 36-1-23 fails to comply with that statute, there will be no penalty to the county unit. The city, town, or township's penalty will be certification of the lesser of the unit's prior year budgets, rates, and levies or the unit's proposed budgets, rates, and levies.

And here is the County Council review process:

- Starts in 2016 for Budget Year 2017.
- The previously existing version of County Council Review has been eliminated.
 - Includes elimination of penalties associated with failure to submit to the county council or failure of the county council to correctly complete the review process.
- At the first meeting of the county fiscal body in August, the county fiscal body shall review the estimated levy limits and estimated circuit breaker impacts <u>provided by the Department</u>. (IC 6-1.1-17-3.6(a))
- The county fiscal body may request that representatives from the taxing units in the county attend the meeting. (IC 6-1.1-17-3.6(b))
- The county fiscal body must allow a representative of a taxing unit to comment on the taxing unit's proposed budgets, levies, and tax rates. (IC 6-1.1-17-3.6(c))
- After the meeting, the county fiscal body may prepare and distribute written recommendations to the county's taxing units. If written recommendations are not prepared, the minutes of the meeting shall be distributed by the county auditor. (IC 6-1.1-17-3.6(d))
