Department Head Reports

Ambulance - Garth Kagels has found a new Ambulance in North Carolina. It is a 2015 2WD Van Style G Series Chevy. It is for sale for \$117,000. They said they would trade in the 2011 Blue Ambulance for \$18,000. The cost of this one would be much less than buying one here brand new. There are no miles on the engine. The people selling the ambulance are willing to pay for 2 people to go down and see the ambulance. The council gave permission for Garth to send people to check it out and see if it really is a good deal for the county. If they were to agree to purchase the ambulance, Garth estimates that it be another 3-4 years before they would need another ambulance.

Garth reported that since they have been receiving the Medicaid Reimbursement checks, their cash flow is a lot better.

2nd Probation Officer Salary

The council questioned the 2nd Probation Officer's Salary request of \$45,000. That amount requires 4-9 years of experience. The Judge will be contacted regarding the experience of the new probation officer and the mandatory pay scale.

"Healthiest You" program

The Commissioners reported to the Council that they had met recently for a quarterly meeting with Keystone & UMR reviewing the medical claims which are down 46% from last year for health insurance. Over 70 people took advantage of the "Healthiest You" program this year that the county pays a premium of \$8 per employee per month, which has saved the county over \$28,000. HSA will be looked into for the year 2018.

Galloway Hog Farm expansion

Jim McKee believes that you cannot enforce the current Zoning Ordinance that the previous Commissioners approved and that the Plan Commission and or Advisory Board needs to rescind the Hog Confinement Ordinance that is out dated. He thinks that it should be looked into further before any decisions are made.
