## Judge Campbell - re: CASA budget & Bi County Accountability

The Budget pertaining to CASA was lowered to \$5,000 which makes it so her grant will be less. She asked the council to raise the amount back to \$7,000 where it has always been so that they can receive the funds they need to keep the program going. The funds are used to train the volunteers that help out with the program. The program saves the county a lot of money in lawyer fees. The auditor will have to advertise for the additional appropriation of \$2,000. It will be voted on at the next meeting.

The Bi County Accountability program that is shared with Warren County has an agreement with our County that Fountain County will pay \$10,000 a year towards the cost of the program. In 2013 & 2015 the invoice was not turned in. There is a discrepancy of when certain invoices were paid and for what years. It is going to be further looked into and a decision to be made to pay the outstanding invoices.

#### **PAW N' CLAWS - Contract**

The current contract pays \$5,000 a quarter to them for their assistance with picking up animals. Paws N' Claws can no longer be of assistance for \$20,000 a year. The City of Attica has gotten too many complaints about their facility. They will have to move or not take as many animals. They said they could possibly do the contract for \$28,000. If they can't take more animals, their service is of no use to the county. Other options brought up were if the county would build a shelter near Solid Waste and Paws N' Claws would lease out the building. Either way, it is cheaper for the county to continue with them rather than building and hiring people to run the facility. No decision was made.

Terry Martin was appointed the County Attorney by the Commissioners at their meeting on Monday, December 19, 2016 to be effective December 25, 2016 due to Daniel Askren being elected as County Prosecutor.
