The Judge has requested that the 2nd Probation Officer, Chris O'Brien be certified to carry a gun in the courthouse. The Ordinance has not yet been approved by the Commissioners.

Highway Dept. - Bud Peach

Community Crossing Grant Program Application Assistance – quotes

PCS - \$14,576 HWC - \$30,000 B F & S - \$32,000

Based on the criteria of the grant: since Fountain County is below the population of 50,000 the match would be 25/75 and Bud wasn't sure that it would be worth doing. Otherwise, it is a 50/50 match grant for counties with a population over 50,000 with \$260,000,000 that will be divided amongst 92 counties in the state of Indiana. Bud will be going to a meeting in May to get more information. The County has 30 days to decide if they will be participating in this grant program. INDOT will need to approve it.

Ambulance - Garth Kagels

A quote from Keller PC has been given in the amount of \$3,560.00. This amount would cover a new controller board, syncing existing locks and troubleshooting and diagnostics. Garth is checking to see if they can simplify the system and will table the quote and look at other options for now.

A motion was made by Jim Hershberger and seconded by Joe Whittington to approve the Keller PC quote and pay out of (4932) Co. Gen. Maintenance to fix the door locks if the Commissioners and Garth find that it is feasible to do because of the complexity of the system.

Vote: 5-0

Garth reviewed 2015 and 2016 monthly run logs and account receivables beginning and ending balances to show the consistent trend of recovery 72% of the collections.

HB1450

HB1450 has been voted through both the House and the Senate for Fountain County to impose a local income tax on the residents in 2018 of not more than (.55%). The Council will need to pass an Ordinance to impose this tax. A County Jail Revenue Fund will need to be established to be used only for the purposes described in Section 25. IC 6-3.6-7-8.5 which applies to Fountain County. The Governor still needs to sign this bill. The County will need to work with several agencies for construction control, bonds, etc.
