PETITION-VAN BUREN TWP Karen Seibold

Since there are 2 Firemen on her board, the council needs to approve her Non-binding budget. The council took a copy of their budget and will look it over and act on it at the next meeting in September when they adopt the budgets.

BUDGET HEARINGS

Bud Peach (County Highway), Garth Kagels (Ambulance), Bob Cates (Veteran Service Officer), Bill Sanders (Sheriff), Commissioners/Brenda Hardy (Auditor), Stephanie Campbell (Judge), Daniel Askren (Prosecutor), Kathleen Wesley (E-911), Wanda Taylor (Recorder), Colleen Chambers (Treasurer), Josh Whittington (Coroner), John Kirkpatrick (Soil & Water), and Courtney Stierwalt (Purdue Extension) were all seen the council to discuss their budgets for 2018. The Assessor's, EMA, LEPC, Health, LHM & Health Trust and Co Drug Free Community were also discussed without representation.

Budget Review

The council needs to cut \$800,000 from the County's Budget. The LIT funds for CEDIT and Public Safety are all going to receive less funds in 2018.

County Highway - Bud Peach

He requested an increase in pay for his employees, stressing that they are all very hard workers. The cost for bridge inspections and building repairs have increased. He would like to get the highway garage painted and fix up the truck garage. Another big increase would be the group health insurance. This will affect all departments. He asked for the opportunity to hire another employee for part time work in the summer. Retirees within the county would work out the best.

With the State wanting the counties to keep better track of their inventory, a new loader is going to be needed that weighs each load.

Ambulance - Garth Kagels

He is requesting a 4% salary increase for his employees. He explained his reasoning for medical supplies increasing so much on next year's budget as being because the medical supplies have nearly tripled in price since 2010. He also is requesting an increase in the computer maintenance line item for a computer system that does the scheduling and keeps track of clocking in and out.

Veteran Service Officer - Bob Cates

A request for a 2% pay increase was the only change for the 2018 budget.

Sheriff - Bill Sanders

He has requested 2 more deputies, 1 Jailer, 2 vehicles and a 5% salary increase. Also, for the Sheriff pension, he has requested that they go with the 26 year policy as an incentive for senior officers to stay on the department.

The council decided to take the vehicles out of their budget and look at taking the money out of Public Safety or County Farm. Three of their vehicles have more than 100,000 miles on them. The council requested a list of cars and their mileage be brought to the next meeting.

They are trying to not take inmates to Warren County Jail. They have gotten hurt there and it costs Fountain County more money.

Auditor - Brenda Hardy

She asked for a 3% raise for her employees and additional pay increase for the 2 that do HR/Payroll in the office. They are certified in HR which is considered a consultant. With the increased work load due to FLSA guidelines, (ACA) Affordable Care Act, disputes, dept. of labor investigation, Internal Control duties assigned to Auditors Office, etc.

Judge - Stephanie Campbell

The state took away funding for the small claims/traffic Judge. The county will have to pay for it themselves. To help in funding for this, she is invoking probation collection fees where the person will not be let off of probation until their fines/fees are paid in full. She is hoping this will cover the extra expenditure for the county. She also raised the budget in computer maintenance. With their new system, they may need new computers if their current ones can't handle it.

Treasurer - Colleen Chambers

She requested a 2% salary increase and asked for an increase in travel. She will not be able to go to an AIC class on cyber security because, there isn't enough funds.

Solid Waste - Colleen Chambers

Solid Waste as well as all departments has a group insurance increase. She requested a 2% salary.

Prosecutor - Daniel Askren

He requested a 3% salary increase for his employees. Everything else on his budget remained the same. With E-Filing, he is hoping it will cut down on paper and ink.

Recorder - Wanda Taylor

Computer Maintenance showed an increase because they will be needing a new server. The council said they should be able to take it out of the Recorder's Perpetuation Fund.

E-911- Kathleen Wesley

She requested a 4 % increase in salary. She has 6 operators. She is short 2 operators. She also would like to make one of the operators an Assistant Director. She is having a hard time filling that position.

Clerk - Paula Copenhaver

She requested a 3.5% increase in salary. Also, she is working on having the bank fees lowered. They are getting out of hand. Tablets will have to be purchased if the county goes to being a Vote Center County. The books are called E-Pole and cost \$28,000 each.

Purdue Extension - Courtney Stierwalt

Increases for her employees at a 2% increase and a 1.5% increase for the Educators which is set by Purdue.

Coroner - Josh Whittington

He is in need of a new camera and laptop. All of the equipment that he has is not up to date. Autopsy expenses needed to be increased as well.

Prosecutor - Daniel Askren

He requested 3% increase in salaries for the IV-D Administrator, Clerk, and Secretary.

A motion was made by Tom Booe and seconded by Bill Glover to approve the transfer of \$5,000.
