## **Don Hesler - County Highway Stipend**

He came to the council to express his desire for the County Highway department to receive a stipend for the work that they have done this year on paving the roads. He feels that the department has saved the county money and should be rewarded for their efforts. Some of the council members agree that they should have the incentive, but are not sure of the effects it would have on the other departments in the county.

#### **Grants**

Joe Whitaker has applied for 2 grants and was approved for both of them. One was in the amount of \$42,365.40 for the purchase of Courthouse Security Cameras and the other is in the amount of \$46,682.00 for the purchase of a new EMA Truck.
