Constellation - Michael Fahrbach

The county has been buying gas from Constellation since 2014. Since the new jail is modeled after another jail, they will be able to contact them and see what the usage is that they use and project the use for the new jail. There are options for fixing the cost of the gas. It is at an all-time low right now and is a great time to lock in the cost. No decision has been made.

Commissioners - updates

A Jail meeting was scheduled for June 18, 2019 at 10am.

The sidewalks are going to have to be redone. They are in the process of getting a quote for all sidewalks around the courthouse, not just one or two sides. And they need to find out the protocol on the planters. If they need to stay and if the new concrete can be poured around them. There are a lot of things that need done around the courthouse. The prosecutor's office needs better air flow. It is cold in the winter and hot in the summer. A new unit might be necessary.

The chimney is still leaking. The boilers were put in the building in 1983. They need new controls. They are around \$12,000 each. They are doing research to see if it's best to get new controls or a new system.

The clerk's office is in need of fans in their office to better heat/cool the office.

<u>Judge - Upgrading the internet</u>

There is a definite need for the internet to be stronger. The arraignments that are done by video are constantly freezing up and everything takes way longer than it should. They are requesting that the internet is boosted to 100mg for the courthouse and the new jail and go with fibre optic. This would be a 3 month construction process.

There are a few employees that have too much comp time. The Judge is requesting that they are paid out for the extra time. They will use the part time position appropriation line item to pay them out.

EMA - Joe Whitaker

He is requesting funds to build a much needed pole barn. The dimensions would be $60 \times 100 \times 16$.

The cheapest quote that he found is \$57,000 and that includes the 2 garage doors on both side and the electrical. The council is for the building.

Also, he has submitted grants for Reader Boards for the highway, a body scanner for the jail and another grant for EMS.

Extension office - Laura Bush

She introduced the new educator - Donnie Gill in the extension office. His title is the Health & Human Service Educator. He started June 3^{rd} .

Valley Oaks Board Members - Appointments

Dudley would like to know if the Council, Commissioners or both appoint board members and how many they each appoint. The Auditor will contact Tom Gilliom, LCSW Chief Executive Officer regarding the representatives to the Board of Directors.

Van Buren TWP - 24 Radios

They need the council's approval for new radios since 2 of their members are firemen. They would like to purchase new radios. The ones they have now are not compatible to anything anymore.
