#### **RESOLUTION 2020-19**

#### FOUNTAIN COUNTY COUNCIL AND FOUNTAIN COUNTY BOARD OF COMMISSIONERS RESOLUTION ESTABLISHING A PROCEDURE FOR CARES ACT REIMBURSEMENT OF PUBLIC HEALTH AND PUBLIC SAFETY PAYROLL COSTS

WHEREAS, on March 6, 2020 the Governor issued Executive Order 20-02 which declared a public health emergency exists throughout the State of Indiana as a result of the coronavirus disease 2019 (COVID-19); and

WHEREAS, the State of Indiana, Office of Management & Budget, issued a letter on May 14, 2020, announcing a direct distribution of Coronavirus Relief Funds (CRF) from the United States Treasury that may be used for the limited purposes set forth in section 601(a) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). Initial guidance from the federal government required that each state may only reimburse expenditures directly related to addressing the COVID-19 pandemic; and

WHEREAS, the Fountain County Board of Commissioners signed the Coronavirus Relief Fund Acceptance Certification in a public meeting on June 15, 2020; and

WHEREAS, the US Department of Treasurer updated on September 2, 2020 the Coronavirus Relief Fund Guidance for State, Territorial, Local, and Tribal Governments, to include payroll expenses for public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID19 public health emergency; and

WHEREAS, the Fountain County Board of Commissioners in a public meeting on October 19, 2020, did vote in favor of requesting the reimbursement of payroll expenses of employees in the public health and public safety departments; and

WHEREAS, a memo issued by State Board of Accounts on September 30, 2020, states that the governing body must adopt in a public meeting an ordinance or resolution that this alternative process will be used for at least part of the CARES reimbursement received from IFA for public health and/or public safety due to the declared health emergency;

NOW, THEREFORE, BE IT RESOLVED by the Fountain County Board of Commissioners and the Fountain County Council:

- The CARES reimbursement for public health and public safety payroll will be receipted into the CARES Fund, fund number 8900 as guided by State Board of Accounts.
- A claim will be created against the CARES Fund for the amount of the reimbursement.
- The money claimed will be receipted into County General, fund number 1000.
- Once receipted into County General, normal appropriation procedures will apply.

\*Prior to filing any open employment position in the County, the Department Head seeking to fill the position shall notify the auditor of the vacancy and the Department Head's intention to fill said vacancy.

The Auditor shall then promptly notify the Commissioners and the Members of the Council giving them an opportunity to provide input prior to the vacancy being filled.

OVERTIME COMPENSATION AND COMPENSATORY TIME

Each County position is designated either as EXCLUDED, EXEMPT, or NON-EXEMPT from federal and state wage and hour laws (such as the Fair Labor Standards Act [FLSA]); and employees holding such positions are treated accordingly:

Employees holding EXCLUDED positions include elected officials, their policymaking appointees, and their personal staff and legal advisors. These employess are not covered by the FLSA, and are not eligible for or entitled to receive overtime compensation or compensatory time off. The following positions within the County are considered Excluded and are not entitled to and shall not receive FLSA overtime compensation or FLSA compensatory

- · All Elected Officials
- Recorder's First Deputy (I.C. 36-2-16-4) Sheriff's Matron (I.C. 36-8-10-5
- Auditor's First Deputy (I.C. 36-2-16-4) · Clerk's First Deputy (I.C. 36-2-16-9)
- Deputy Prosecutor
   Public Defenders
   Sheriff's Chief Deputy (I.C. 36-2-16-4)
   Treasurer's First Deputy (I.C. 36-2-16-4)

Employees holding EXEMPT positions are excluded from specific provisions of federal and state wage and hour laws, and are not entitled to and shall not receive FLSA overtime compensation or FLSA compensatory time off. The following positions within the County are considered Exempt and are not entitled to and shall not receive FLSA overtime compensation or FLSA compensatory time off:

- · Ambulance Director
- Community Corrections Director
- · Highway Supervisor
- Fountain/Warren Regional Dispatch Director

Employees holding NON-EXEMPT positions, whether hourly or salaried, are entitled to overtime pay or compensatory time off under the specific provisions of federal and state laws. All positions within the County except those listed under Excluded or Exempt are considered Non-Exempt and are entitled to overtime pay or compensatory time off.
