### **Department Head Reports**

#### Ambulance - Garth Kagels

They received Medicare Reimbursement from 2019 in the estimated amount of \$10,155.00.

He will be putting in an additional appropriation of medical supplies, Gas & Oil and equipment repair.

Numbers are going up for runs, which means more gas/oil, supplies and potential equipment issues.

They are working with the Highway Department to see if they can get any kind of reimbursement for fuel.

## Clerk - Paula Copenhaver

The election equipment worked well during the election. There were only a couple things that the voter registration volunteers need better training on. The old equipment has encoders that Jasper County would like to purchase. She would like to do that to recoup some costs. She will approach the Commissioners about it.

## EMA - Joe Whitaker

He has applied for 2 grants and should be receiving them soon. A salary reimbursement grant in the amount of \$32,000 and a competitive grant in the amount of \$18,000. That grant is to be used for replacing the ID badge machine and key fobs.

#### Highway - Jason Lewis

There was a public hearing for the Resolutions concerning the Highway Department. He answered any questions that there was. He and Travis expressed concerns about the Enterprise agreement.

## **Sheriff - Terry Holt**

There are currently 68 in jail. Thirty-one of which the County is being paid for. There was an issue with the ordering of the new squad cars with Kelley Chevrolet. They never ordered the cars. Now, they are ordering through Alsop and they should be available by October.

They also proposed that a fence be built around the Jail for added security. Currently, there is not a secure place for inmates to go during a fire drill or extra security by the Sally Port.

The Council asked for them to get some quotes and find out how far out the fence would have to be from the building.

#### **Enterprise Agreement**

Jim Hershberger had a few reservations about the agreement and wanted to have clarification on what a few things were. Such as, trade in value, added equipment etc. The Council would like to have the Enterprise representatives come to a joint meeting so that all questions could be addressed and that everyone could be made aware of the details.

### **Warren County Council**
